JAM Social Media Policy

As we approach a new dance team season, it is important to remember and adhere to the JAM Social Media Policy. Throughout the competitive and post-competitive season, videos are uploaded to YouTube, updates are added to Facebook, and interviews, articles and results are posted on blogs. As officials, it is our responsibility to stay neutral and unbiased on these social media channels. Please take a moment to review our approach with social media.

Any and all comments said or written by a judge can (and will) be deemed the official view of ALL of the judges by dancers, coaches, administrators and the general public. Some repercussions of making comments on the Internet can include:

- It can appear that a judge has a preconceived idea or bias about teams and placements.
- Comments can be taken as offensive and hurtful.
- Comments are misconstrued and are seldom written or interpreted correctly.
- Most information that is interesting enough to post is confidential. Trust is broken with your colleagues when this occurs and can cause fractures in the dance team officiating community.
- Judges who comment on the Internet put our association leadership and the MSHSL in the position of defending the indefensible. These comments damage our credibility as a professional organization.

The Minnesota State High School League has deemed this kind of interaction with the general public as behavior unbecoming an official. The MSHSL, as well as JAM, have policies that officials will not make unauthorized comments to the media. Social media sites are included in these policies. It does not serve our mission to discuss issues that can be misunderstood and misconstrued on these platforms, especially by those who have very strong feelings about dance team. Judges lose the respect of the general public and the dance team community. Judges who would post these comments will ultimately lose the respect of their colleagues, and potentially suffer additional consequences regarding their association membership and/or their MSHSL registered status.

The statements below from the MSHSL Code of Ethics for Officials and the JAM Code of Conduct govern our behavior in regards to social media:

- I understand that my actions as an official must display decisions and behavior which teach students how to compete within the letter and spirit of the rules so that all competitors have the same fair chance for success.
- I will use respectful language at all times.
- I will be neutral and impartial.
- I will treat other officials with courtesy and support their decisions.
- I will uphold the honor, dignity, and humility of my role in all interactions with athletes, coaches, school administrators, colleagues, and the public.
- I will recognize that anything that may lead to a conflict of interest, either real or apparent, must be avoided. Actions that can compromise the perceived impartiality of judging must be avoided.

Keep in mind, if you visit these sites and just read these comments during the dance team season, you will put yourself in the untenable position of having to defend your impartiality - whether perceived or real. Additionally, if you visit these sites, you will be inundated with comments about what a poor job you did. It does not matter how the results turn out. It is a normal part of being an official. However, you have the power to control what you read and what you don't and you will find your officiating experience to be much more worthwhile and enjoyable, if you do not search out criticism.
