JAM and Your Taxes

Several members ask each year about those pesky W-9 forms that schools ask us to fill out, as well as if the fees that we receive as officials need to be claimed on our tax returns. Here's the scoop...

Business and individuals who pay fees to non-employee individuals or businesses (other than corporations) for services performed must track those recipients' identification numbers and the amounts of those payments. If the total amounts paid to any one individual or business exceed \$600 in a calendar year, a 1099 form must be issued to the recipient and copied to the IRS so that the taxing authorities can match those payments to the recipients' returns as proof of income.

So does that mean that our fees are taxable? Not necessarily...since most likely we are performing our officiating services without the intent to make a profit. The IRS classifies these types of activities as hobbies (www.irs.gov, FS 2008-23, June 2008). When an individual engages in a hobby, there is no significant investment or intent to profit from the activity. If expenses are incurred to generate some of the receipts from the hobby ("income"), then those expenses can be deducted from the receipts but only to reduce the net receipt to \$0. In other words, an individual cannot use expenses that exceed the hobby in order to generate a loss and claim a tax write off.

Expenses that we typically have are mileage, which is subject to IRS limits, and supplies such as pens, paper, etc. Simply saving the receipts from any items that you purchase for officiating and keeping track of your mileage are easy ways to document the expenses for this activity. Just in case you do receive a formal 1099 form, you may then have expenses that you can use to offset any income that you may need to claim.

Have additional taxing questions? The CPA Referral Service from the MN Society of CPAs (www.mncpa.org) can match you with a local CPA who specializes in individual tax and can help you file your tax forms correctly – and maybe even save you some extra hard-earned money!

Don't forget to add the varsity teams you judged to your schedule on the MSHSL website! The MSHSL uses these lists, among other criteria, to help identify which officials are best suited to judge each class at the State Tournament in February.

Also, remember to rate the schools after each meet. This information is used by the MSHSL as a way to gather feedback about the sportsmanship and conduct of athletes, coaches and spectators, as well as a way to identify opportunities or accomplishments for particular events.


